INTRODUCTION

The information provided in this report is derived primarily from documents developed at the time the CFD was formed and from data provided by the Water District or accessed through the Water District. The information sources include the Rate and Method of apportionment, annual budget, debt service schedule(s), fund balance(s) and special tax/assessment delinquency data. The development status, prepayments and historical information were accessed through the Water District and/or the developer and are maintained by Willdan Financial Services.

The Mello-Roos Community Facilities Act (“Act”) of 1982 came about as a response to the lack of adequate financing for public capital facilities and services in the post-Proposition 13 era. State Legislators Mello and Roos sponsored this Bill, which was enacted into law by the California Legislature and is now Sections 53311 through 53368 of the California Government Code. The Act authorizes a local governmental agency, such as a school district or city, to form a Community Facilities District (“CFD”) or (“District”) within a defined set of boundaries for the purposes of providing public facilities and services. A CFD is formed for financing purposes only and is governed by the agency that formed it.

A. FORMATION

The CFD was established by the Murrieta County Water District (the “MCWD”) on January 25, 2000, with the adoption of Resolution No. 00-01-25-1. In 2005, MCWD was dissolved and incorporated into the territory of the Water District. Under Resolution No. 40-05, adopted by the Riverside Local Agency Formation Commission on August 25, 2005, the Water District assumed service over the territory of MCWD and also succeeded to all rights and duties of MCWD with respect to the Community Facilities Districts and all outstanding bonds issued in connection therewith.

B. BOUNDARIES AND DEVELOPMENT SUMMARY

The CFD consists of approximately 78.66 gross acres in the City of Murrieta. The CFD is located at the northwestern corner of Nighthawk Way and Washington Avenue and is known as “Murrieta Ranchos”. It has been fully developed with 161 single family residences.

C. BONDS

Pursuant to the Fiscal Agent Agreement dated July 1, 2021, the 2021 Special Tax Refunding Bonds (the “Bonds”) were issued. The Bonds were issued to (i) refund the outstanding Series 2011 Special Tax Bonds (the “2011 Bonds”).

Pursuant to the Official Statement dated September 15, 2011, the 2011 Bonds were issued to (i) refund the outstanding Series 1996 and 2000 Special Tax Bonds (the Original Bonds”), (ii) provide additional funds for construction of water facilities authorized by the proceedings to form the CFD, (iii) fund a reserve fund, and (iv) pay certain costs of issuing the Original Bonds.

D. FINANCED FACILITIES

The CFD was originally formed to finance the construction and acquisition of certain water and sewer improvements and to pay certain school impact fees.

B. FORECLOSURE COVENANT

Pursuant to the Act, the Water District hereby covenants with and for the benefit of the owners of the bonds that in will order, and cause to be commenced as hereinafter provided, and thereafter diligently prosecute to judgement (unless such delinquency is theretofore brought current), an action in the superior Court to foreclose the lien of any special tax or installment thereof not paid when due as provided in the following two paragraphs. The Authorized Officer shall notify the counsel to the Water district of any such delinquency of which it is aware, and the counsel to the Water District shall commence, or cause to be commenced, such proceedings.

On or about July 15 of each Fiscal Year, the Authorized Officer shall compare the amount of Special Taxes theretofore levied in the CFD to the amount of Special Tax Revenues theretofore received by the Water District and:

If the Authorized Officer determines that any single parcel subject to the Special Tax in the CFD is delinquent in the payment of Special Taxes in the aggregate amount of \$2,500 or more, then the Authorized Officer shall send or cause to be sent a notice of delinquency (and a demand for immediate payment thereof) to the property owner within 45 days of such determination, and (if the delinquency remains uncured) foreclosure proceedings shall be commenced by the Water District within 90 days of such determination to the extent permissible under the County’s Teeter Plan program and applicable law.

If the Authorized Officer determines that (i) the total amount of delinquent Special Tax for the prior Fiscal Year for the CFD exceeds 5% of the total Special Tax due and payable for the prior Fiscal Year, or (ii) there are ten (10) or fewer owners of real property within the CFD, determined by reference to the latest available secured property tax roll of the County or other official records of the County, then

the Water District shall notify or cause to be notified property owners who are then delinquent in the payment of Special Taxes (and demand immediate payment of the delinquency) within 45 days of such determination, and shall commence foreclosure proceedings within 90 days of such determination against each parcel of land in the CFD with a Special Tax delinquency.

C. DELINQUENCY MANAGEMENT ACTIONS

There is no single property owner delinquent of \$2,500 or more and the total amount of delinquencies in the CFD for the prior Fiscal Year does not exceed five percent (5%) of the total Special Tax due for the prior Fiscal Year. However, Willdan Financial Services has taken the initial steps toward foreclosure proceedings or reducing delinquencies by performing the following Delinquency Management Actions since July 1, 2024.

IV. SPECIAL TAX LEVY AND METHOD OF APPORTIONMENT

The methodology employed to calculate and apportion the special tax is in accordance with the document entitled Rate and Method of Apportionment (“RMA”). The RMA is hereby referenced and summarized but not included in this report, however the official document can be requested and provided by the Water District’s special tax administrator Willdan Financial Services.

A. RATE AND METHOD OF APPORTIONMENT

Pursuant to Section D of the Rate of Method of Apportionment, commencing with Fiscal Year 2000/01 and for each following fiscal year, the CFD shall determine the Special Tax Requirement and shall levy the Special Tax until the total Special Tax levy equals the Special Tax Requirement. *(FOR DETAILED INFORMATION OF THE SPECIAL TAX REQUIREMENT, PLEASE REFER TO SECTION (II) FINANCIAL OBLIGATIONS ABOVE).*

The Special Tax shall be levied on each Assessor’s Parcel of Developed Property up to 100% of the Maximum Special Tax. If additional monies are needed to satisfy the Special Tax Requirement after the first step has been completed, the Special Tax shall be levied Proportionately on each Assessor’s Parcel of Undeveloped Property up to 100% of the Maximum Special Tax for Undeveloped Property.

Developed Property means for each fiscal year, all Taxable Property for which a final tract map was recorded prior to January 1 of the prior fiscal year.

The CFD has been fully developed with 161 single family residences.

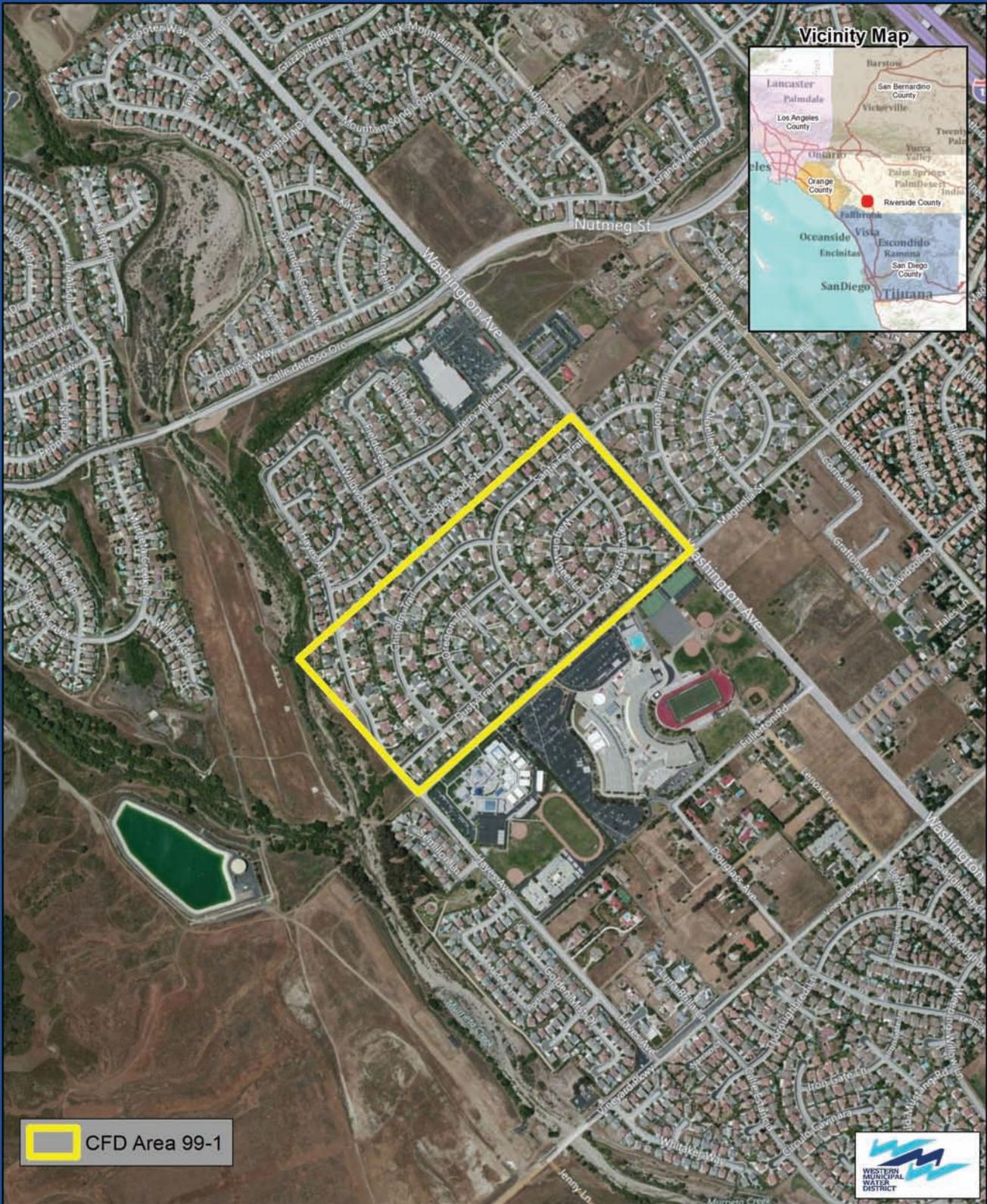

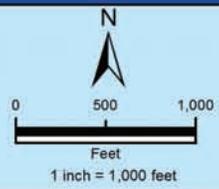
Boundary Diagram
